Metropolitan Bridge Unit of New York Zero Tolerance Policy

The Metropolitan Bridge Unit is enforcing a Zero Tolerance policy in all clubs in the unit. The policy in effect is based upon the ACBL [Zero Tolerance Handout for Clubs](#).

Everything a director needs to effectively administer disciplinary action resides in the [Laws of Duplicate Bridge](#).

Law 74: A Player should maintain a courteous attitude at all times. A player should carefully avoid any remark or action that might cause annoyance or embarrassment to another, or might interfere with the enjoyment of the game.

Law 90: The Director may assess penalties for any offence that unduly delays or obstructs, the game, or inconveniences other contestants.

Law 91: The Director may assess procedural penalties in points, or suspend a contestant for the current session or any part thereof. The Director's decision under this clause is final.

After a complaint has been received from a player about an incident, there will be a response in writing from the director with the penalty to be assessed if any. A penalty assessed by a club is not binding on another club, but multiple complaints may have unit-wide consequences.

This policy will only affect local club activities, and not tournament events, and the unit will maintain a file with all zero tolerance complaints.

The merger of the Mid-Atlantic Section and Eastern Section is complete. With resources joined the ABA deemed it cost-effective, post Covid, to consolidate the sections while maintaining the bridge-playing experience members are accustomed to. Our historical archives record that the Mid-Atlantic Section was formed in 1980 brought about by the size of the Eastern Section and geographical factors.

Our "new" Eastern Section includes Massachusetts, New York, New Jersey, Pennsylvania, Delaware, Maryland, Washington D.C., Virginia, North Carolina, South Carolina, and numerous independent clubs. In addition, a website will be developed to cover news and activities.

It was a good sight to see a conference room filled with ABA members, checking out familiar faces at the first new Eastern Section membership meeting held at Resorts Hotel and Casino in Atlantic City, New Jersey on May 24, 2023. Vice President Lynda Straker presided at the meeting providing clarity when needed. For example, the difference between an independent club and unit club. It is a matter of distance. The Director's Corner

DEFENSE

If you're Third Hand (partner has led the suit):

- ♦ Play "**Third Hand High**" rule to set up potential tricks for your side. Play the highest card necessary to force declarer or dummy to win with its high card.
- ♦ Always play the **lowest of touching cards** to give partner the most information about your strength. (Play the J from QJx; the 9 from J109.)
- ♦ If you're playing after dummy, be sure to **bracket** your honors if dummy plays low. (Play the J from KJx if dummy plays low from Qxx.)

If you're Second Hand (declarer or dummy is leading the suit):

- ♦ If an honor is led and you're next to play, follow the "**Cover an Honor with an Honor**" rule -- if declarer or dummy leads an honor (10 through Ace), play your higher honor on it if you have one. This forces declarer to use two of his honors to capture one of yours.
- ♦ With most other holdings, follow the "**Second-Hand Low**" rule (if you're in doubt about which card to play, choose a low card).

The main exceptions to the second-hand-low rules are:

1. You have a sequence of honors (KQJx, QJ10xx, etc.) and want to be sure you force declarer to win a high card. In this case, play the **lowest** of touching honors.
2. You're covering an honor with an honor, or playing your ace to win a king or queen.
3. You're reasonably sure your ace will be trumped later if you don't take it now.

If you're on lead after the first trick:

- ♦ If partner made the opening lead -- and if you're in doubt about what to do when you gain the lead later in the hand -- return partner's suit. This is an especially valuable guideline to follow when defending notrump contracts.
- ♦ If you want to switch suits, choose to lead **through** strength and **up to** weakness. Ideally, you want the opponent who holds the most strength in a suit to be the **second** hand to play to the trick. You want the hand with weakness in the suit to be **fourth** to play to the trick.
- ♦ Don't be afraid to lead a suit that you know declarer will trump -- you can sometimes weaken his trump holding by doing so.

- ♦ Don't be afraid to lead a trump. If it appears that your other possible leads will risk giving declarer a trick, a trump can sometimes serve as a safe exit.
- ♦ **Don't** lead a suit if **both** declarer and dummy are void. This is called a "ruff-and-sluff," and it often gives up tricks by letting declarer trump in one hand and throw a loser from the other hand.

The Rules

Rule of 15

When there have been three passes and deciding whether to open light in fourth seat, you can count the number of high card points and the number of spades you hold. If the total is at least 15, you may open.

Rule of 160

If the ages of your opponents add up to 160, don't underestimate their ability.

VICTORIA DOINGS.

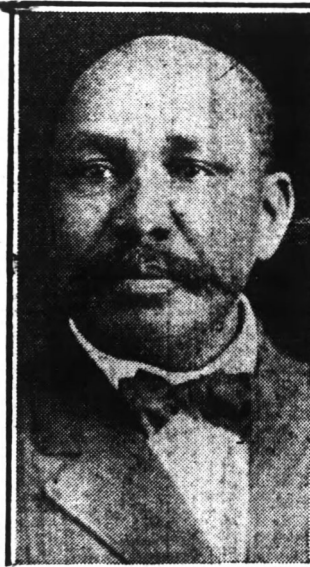
Victoria, Tex., April 4.—The progressive colored people of this county have organized the Emancipation park and fair association. The objects of the association are to obtain a permanent site for holding their annual emancipation celebration and other matters pertaining to the general welfare of the race. They have obtained a charter. E. W. Gross is secretary.

EMANCIPATION DAY OBSERVED FRIDAY

Parade Attracted Considerable Attention.

Old Ex-Slaves Were Treated to Old Time Dinner at Park Where Talks and Orations Were Features.

Was honored by negroes for having loaned \$1000 to save Emancipation Park from being sold for debt.

Floats portraying several phases of negro industrial life in Houston were the features of the Emancipation day parade, which attracted considerable attention on the streets at noon Friday.

Owing to difficulty in collecting the floats and carriages at the starting place on Travis street, the parade was late in starting, but Milam street was lined with negroes the whole time, awaiting the coming of the procession, and when finally it did emerge onto Milam street it was greeted with a flutter of handkerchiefs.

Immediately behind the marshals of the parade came a float bearing a number of ex-slaves. Following that float came a number of decorated wagons, among them being floats showing street car track construction, cooking, paving, laundry work and one brewery was represented with a wagon showing a phase of its work. Other floats bore children and women. In all there were over 20 floats and several hundred negroes participated in the procession. Two bands furnished the music.

After parading on several downtown streets the procession moved down Main and thence to Emancipation park, where the two days' festivities began.

The parade reached the grounds at about the noon hour. The several groups soon dispersed and lost their identity among the thousands gathered at the

park. A number of old ex-slaves, who had gathered to enjoy a special barbecue dinner, were kept together until the meal was spread.

The prayer was said and the old negroes joyfully began carving away at the nice brown, juicy meat, sandwiches with pickles, sauce and salads. It was an interesting sight to see these old negroes enjoying themselves on their Emancipation day.

Following the meal the old slaves repaired to the grandstand and enjoyed a sermon preached by Elder Watts. Although almost blind the old man delivered a good sermon.

At the close of the sermon the band played the "Star Spangled Banner," and the audience was called to order by Charles F. Smith, who acted as master of ceremonies. He introduced Rev. C. W. Holmes, grand chaplain, who delivered the invocation. Prof. B. H. Grimes, grand president, was introduced. He made an excellent talk and in turn introduced Prof. L. B. Kinchion of Belton, orator of the day.

Professor Kinchion delivered a practical and instructive address. He dwelt upon the need for more race pride and unity among the negroes. Among other things he said: "No, it is not the fault of the white people that we have made no further substantial progress. It is the fault of our own lack of race pride and unity. You Houston negroes are spending more time trying to keep your leaders down than you are using for your own development. We must look to the white man for so much assistance. We should do something for ourselves. All we need from our white brother is his sympathy and a square deal. We want the same justice and mercy he gets and we want only the same punishment or reward that he gets. Just a square deal."

Freddie Lee Lights delivered an oration on the "Power of Liberty." Charles F. Smith called attention to a short address to the value of a worthy citizen. He paid a glowing tribute to J. B. Bell, who let the present board of trustees have \$1000 to lift the first mortgage note on the park.

F. A. Martinier, a member of the present board, loaned \$150 to pay interest, without himself charging any interest.

At the close of the meeting the following resolutions were read and adopted:

"Whereas, J. B. Bell came to the rescue of the Emancipation park board by lending \$1000 to save the park from foreclosure; and,

"Whereas, F. A. Martinier, member of the board, loaned \$150 on the debt, be it

"Resolved, That this assembly show appreciation to these two worthy sons of our race by extending to them a standing vote of thanks."

The resolution was adopted and the audience stood up.

At night the park was crowded.
