

The American Bridge Association held its General Meeting via Zoom on August 26, 2021. The opening prayer was given by Dr. Errol Grant who offered that our leaders make wise decisions and that we be a blessing to each other. Harold Bickham, president of the association, called the 90-minute meeting to order reaching 255 registered members. The current National Officers — President Harold Bickham, Vice President Mae Clark, Secretary Gloria Christler, and Treasurer Shirley Williams — consented to continue to serve in their respective offices as no other Letters of Intent were submitted to the Election Committee. One unanimous vote was cast in favor of the uncontested slate of candidates.

The association's financial standing is solid, with 49 percent of fiscal 2021 budgeted revenue realized as of June 30, 2021. ABA/BBO

online revenue, membership dues and charter fees account for 79 percent of revenue. Among the challenges faced by the association are increasing membership as our numbers have declined during this pandemic, striking a balance between online and face-to-face bridge, and updating the association's Bylaws and Handbook to comport with today's environment.

Good news for members — you will receive \$5 discount on National dues when you pay by November 30, 2021. New members who took bridge classes and joined during 2021 will receive 2022 dues free.

# The Opening Bid

By Dr. Errol Grant

When we pick up our hands, we all sort quickly to see if we have the magical 13 HCPs or more. If that's the case, we settle back in our seats and prepare to have a good time. If our hand is less than the expected 13, then it becomes should I or should I not venture an opening bid. Let me share some guidelines that will lead you to reasonable considerations.

In first or second seat, strive to open with 13 points; but wait a minute, all 13 points don't have equal strength.

Consider these three hands:

- |            |             |            |
|------------|-------------|------------|
| 1. ♠ Q 9 3 | 2. ♠ Q J 10 | 3. ♠ K 9 8 |
| ♥ Q 7 5    | ♥ Q J 10    | ♥ K 10     |
| ♦ A J 3    | ♦ A J 10    | ♦ A 8 7 4  |
| ♣ K J 4 2  | ♣ Q 9 6 2   | ♣ K 9 8 4  |

In hand 1, the Q's are not protected and may never produce a trick. This implies you have 8 losers.

In hand 2, the Q's are protected and will produce a trick but the rest of the hand is not very productive; again, 8 losers.

In hand 3, you have "stuff" -- good intermediates backing up your K's and A; 7 losers.

I would not have much confidence in opening hands 1 and 2 but surely hand 3.

There is a useful tool to assist you in determining whether to open the bidding or pass -- it is called the Rule of 22.

## Rule of 22

Add the number of cards in your two longest suits to your HCPs. If that total comes to 20, then you can go to the next step. If not, proceed no further. If the total does come to 20, look for two defensive tricks; hence, 22 = 20 + 2.

A defensive trick means that if the opponents win the contract, you can produce two tricks on defense.

Here is how to evaluate defensive tricks:

A = 1    K = 1/2    AK = 2    KQ = 1/2

Go back and check the hands above. Do they meet the criteria? Only hand 3 does, so you pass with 1 and 2 and open with 3.

Our discussion so far assumes balanced hands. With unbalanced hands, especially "wildly" unbalanced hands, while the Rule of 22 guides you, if the opponents win the contract be aware that even your defensive tricks may not produce a trick since opponents may be void. So, do not yield to the temptation to double. Here is an example:

- |                |   |
|----------------|---|
| ♠ -            | Opponents find themselves in 6♠.  |
| ♥ A 10 9 8 7 6 | Do not double because you have two A's.   |
| ♦ J            | You have a VOID so they are likely to have a VOID also. We refer to that as symmetry. |
| ♣ A J 10 8 5 4 |   |

So, what about opening hands on the edge? What would you do with the following hands?

- |                   |                |
|-------------------|----------------|
| 1. ♠ A 10 9 8 7 6 | 2. ♠ A K 6 5 3 |
| ♥ -               | ♥ K J 10 9     |
| ♦ A J 10 8 6 5    | ♦ 6 5          |
| ♣ J               | ♣ 8 4          |
| 3. ♠ 8            | 4. ♠ 5         |
| ♥ 2               | ♥ K Q J 10 8 6 |
| ♦ K Q J 8 5       | ♦ Q 10 7 5     |
| ♣ A J 10 9 6 3    | ♣ K 2          |

With hand 1, I would open 1♠ planning to rebid 5♦ next if I don't hear something favorable from partner.

With hand 2, I would open 1♠ with an easy rebid of 2♥.

With hand 3, I would open 1♦; then 5♣ giving partner a choice.

With hand 4, 2♥ you say? I would open 1♥, too good for weak opening.

Too rich for your blood? Try them.





All players should get a copy of the club’s guidelines. Also, determine who will be monitoring each player’s adherence to the guidelines and how. For example, if someone arrives and is coughing and/or sneezing, whose responsibility is it to address that individual and make decisions about their ability to play in the game?

Thank you everyone who is supporting the Bridge Home through direct or indirect donations. We need to support each other to come out of this pandemic in a way that we can move forward with energy and enthusiasm for bridge. The MBU Executive Committee plans on a “reopening celebration” at some point which is to be funded by the proceeds from our MBU Big Apple BBO Open Pairs game. Speaking of the MBU Big Apple BBO Open Pairs game, it is now a 12-board virtual game held at 2:00 pm on Tuesdays. We need everyone’s participation to keep this game going and to maximize contributions to the MBU bank account.

As suggested at our last meeting, online bridge lessons are being conducted by Willie Fuchs on Mondays and Fridays at 9:30 am and on Thursdays at 9:00 am. The Monday/Friday sessions are on a variety of bridge topics and the Thursday classes are on Two Over One. All are invited and Willie asks that participants make donations to the Bridge Home in lieu of payment for his lessons. It is great to see MBU members and people we know from other sections around the country on BBO. I’m sure it will be very exciting when we get to meet again face to face. ## Guidelines for Face-to-Face Bridge

### **Safety Procedures**

Units and clubs, in planning when and how to run events, should determine the safety procedures they will employ, guided by CDC, local (state/city/county, as applicable) regulations on group size for indoor gatherings of various types, mask wearing, distancing, cleaning of surfaces, evidence of vaccination, and other relevant factors.

### **Bridge Player Requirements**

- ◆ Full COVID-19 vaccinations are required for each bridge player and any persons within the playing area. Players must bring proof of vaccination. (Please note: DO NOT take a photo of each person's vaccination card. Just note that they presented one on the liability form.)
- ◆ The ABA Release of Liability must be read and signed by each bridge player and any persons within the playing area.
- ◆ Players and any persons within the playing area are encouraged to wear a mask.
- ◆ If you are sick, have a fever, are coughing or sneezing, please stay home.

### **Bridge Club Boards, Playing Cards, Bidding Boxes**

- ◆ Wipe boards and bidding boxes clean before duplication.
- ◆ Store boards for 72 hours before reuse.
- ◆ Bidding Boxes – Individual bidding boxes should be used throughout the game.

### **Preparing the Playing Room**

- ◆ Limit the number of tables in the room to ensure there is legal spacing between tables. Suggested 3 feet apart.
- ◆ Ensure alcohol-based hand sanitizer or hand wipes supplied by the club are readily available at each table.
- ◆ Ensure face masks supplied by the club, if required, are readily available for those who neglect to bring one.
- ◆ Recommend there are disposable gloves available.
- ◆ Catering – Determine if it is safe for persons to bring their own snacks and beverages. Only individually wrapped snacks and beverages are permitted. No communal coffee and condiments allowed.



## Waiver of Liability

The ABA has provided a waiver of liability form (see below) to be signed by attendees at ABA-sponsored events when face-to-face bridge games resume.



### **American Bridge Association, Inc. COVID-19 Participant Waiver of Liability, Acknowledgment, and Assumption of Risk Agreement**

The 2019 novel coronavirus (COVID-19) has been declared a worldwide pandemic by the World Health Organization and a national emergency in the United States. COVID-19 is highly contagious and, as a result, social distancing is recommended by federal and state health agencies. The American Bridge Association, Inc. (ABA) has implemented reasonable preventative measures to reduce the spread of COVID-19 among participants and attendees (Participant) at ABA tournaments and other activities and events. However, given the nature of the virus, there is an inherent risk of being exposed to, or even contracting, COVID-19 by attending and/or participating in an ABA tournament or any other ABA-sponsored event.

Even though current safety protocols recommended by the United States Centers for Disease Control and Prevention (CDC) and state and county health agencies will be followed to the fullest extent possible, the ABA cannot guarantee that a Participant will not become infected with COVID-19. Participants must understand and acknowledge that attending ABA tournaments and any other events could increase their risk of contracting COVID-19.

By signing this COVID-19 Participant Waiver of Liability, Acknowledgement and Assumption of Risk Agreement (Agreement), as a Participant, I agree and acknowledge that:

1. I am aware of the highly contagious nature of COVID-19 and the risk that I may be exposed to, or contract, COVID-19 by participating in ABA-sponsored tournaments and other ABA-sponsored events.
2. I am familiar with federal, state, and local laws, orders, directives, and guidelines related to COVID-19, including the CDC guidance on COVID-19 (Applicable Laws).
3. I will comply in all material respects with all Applicable Laws at all times while participating in ABA-sponsored activities or tournaments, including, without limitation, requirements related to hand sanitation, social distancing, vaccination, and facemasks/face coverings.
4. I agree not to enter any space that the ABA has obtained for any event or to participate in any ABA-sponsored activity or tournament if any of the following is true:
  - a. within the last 10 days, I have experienced symptoms of COVID-19; or
  - b. within the last 10 days, I have had a positive COVID-19 test.



5. I agree not to enter any space that the ABA has obtained for any event or to participate in any ABA-sponsored activity or tournament if any of the following is true and I have not completed my vaccine series (i.e., two doses of Moderna and Pfizer or one dose of Johnson & Johnson) more than two weeks ago:
  - a. within the last 14 days, I have been on a cruise ship or river cruise voyage; or
  - b. within the last 14 days, I have had close contact (defined as contact within less than six feet for a total of at least 15 minutes) with a person or persons who have had a positive COVID-19 test.
6. I understand and acknowledge that any such exposure or infection may result in serious illness, personal injury, permanent disability, death, or other damages.
7. I understand that, while the ABA has implemented preventative measures to reduce the spread of COVID-19, the ABA cannot guarantee that I will not become infected with COVID-19 while participating in any ABA-sponsored activities or tournaments, whether from actions, omissions, or negligence of others, including ABA employees, contractors, volunteers and other Participants.

As a Participant, I knowingly, voluntarily, and intelligently agree, individually and on behalf of myself and my heirs and family members, to hereby release, discharge, and hold harmless the ABA, its employees, contractors, volunteers and other Participants of and from any and all claims, actions, damages, costs, or expenses of any kind arising out of or related to any COVID-19 related illness (Claims). I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the ABA, its employees, and other Participants whether a COVID-19 infection occurs before, during, or after attending an ABA event or participating in an ABA activity or tournament.

By signing this Agreement, I agree that if I am exposed to or infected by COVID-19 while participating in any ABA activity or tournament, then I may be found by a court of law to have waived my right to maintain a lawsuit or arbitration against the parties being released on the basis of any Claim.

I acknowledge and agree that this Agreement shall be governed by the laws of, and deemed to have been executed in, the State of Indiana without reference to conflict of law principles. In the event that I file a lawsuit or seek arbitration, or if my heirs file a lawsuit or seek arbitration on my behalf, the appropriate state or federal court for Atlanta, Georgia is the exclusive jurisdiction, forum, and venue for any such dispute, and I further agree that the substantive law of the State of Indiana shall apply. I agree that, if any portion of this Agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect. By signing this Agreement, I consent to personal jurisdiction in the State of Georgia, waive any right to challenge (and agree not to challenge) the convenience of the stated forum; and waive any right to challenge (and agree not to challenge) the properness of the stated venue.

As a Participant, I have had sufficient time to read this entire document prior to signing. I have read and understand this document and I agree to be bound by its terms.
